Important Considerations:

- 1. It is recommended that you submit your visa application at least 1 month before your planned travel date. According to the relevant legislation, visa applications must be finalized within a maximum of 90 days. In practice, applications are usually finalized in shorter periods.
- 2. According to international practice, the issuance of a visa does not mean that a foreigner can certainly enter the country where he/she has obtained the visa. Permission to enter the country is granted by the relevant officials upon arrival.
- 3. The visa fee can only be paid in cash in US Dollars.
- 4. The visa fee paid is non-refundable under any circumstances, even if your visa application is rejected.
- 5. All visa applicants are required to have travel health insurance that covers the duration of their travel and is valid in Türkiye (Work visa applicants, diplomatic passport holders and first-degree relatives of a Turkish citizen whose insurance also covers the visa applicant are not required to have travel health insurance).
- 6. All visa types allow a maximum stay of 90 days. No visa type allows you to stay in Türkiye for more than 90 days in the last 180 days. In order to stay in Türkiye more than 90 days, you need to obtain a residence permit from the relevant authorities in Türkiye.
- 7. For all visa applications, your passport must be valid for at least "6 months + duration of your stay in Türkiye". In addition, your passport must have at least 2 blank pages.
- 8. For visa applications of children under the age of 18 coming to Türkiye for any purpose, the consent of both parents must be obtained. In order to issue a visa, a custody document or other relevant documents must be submitted in visa application for those whose parents are separated or who declare that one of them is not alive. Persons under 18 years of age cannot apply for a visa directly. One of the parents or another foreigner to whom the parent has given a power of attorney / consent officially in a notary can apply for a visa for a foreigner under the age of 18.
- 9. A person who arrives at the border gates in order to enter or transit through Türkiye, but is not allowed to enter or transit through Türkiye because he/she does not meet the conditions required by the legislation is considered as a inadmissible passenger (INAD).

- 10. A deportation order is taken against a foreigner who does not have the right to stay in Türkiye in order to remove him/her from the country. (Please pay attention to the duration and rules of your stay in Türkiye in order to avoid the deportation order).
- 11. A visa does not provide the right to work. If you wish to work in Türkiye, you must obtain a work visa from the diplomatic representative offices of the Republic of Türkiye in your country of citizenship or legal residence.
- 12. The visa for tourism purposes is valid only for tourist trips.
- 13. In principle, the visa application must be made in person. It is not possible for a foreigner over 18 years of age to apply for a visa on behalf of someone else.
- 14. Foreigners with a valid residence permit or work permit on the date of entry into Türkiye may enter Türkiye without a visa.
- 15. The visa applications for education, training and work purposes and visa applications of persons who are prohibited to enter to Türkiye take longer than other applications. Please pay attention to this issue when making your application.
- 16. It is not possible to pay the fines for violating visa, residence or work rules of Türkiye to our Embassy. You can only pay these fines at the payment points in the airports.
- 17. Phone inquiries will be answered only between 9:00-10:00 and 16.00-17.00 on weekdays. Outside of these hours, Consular agents will not be accessible by phone. For any queries, feel free to reach out to us via email or our social media accounts 24/7. Email: embassy.dushanbe@mfa.gov.tr

18. Please be informed that approved visas are available for collection by applicants at the Embassy between 16.00-17.00 hours on weekdays only.

Visa application process:

- 1. For all visa applications, you must first make a visa pre-application on the website www.visa.gov.tr, make an appointment and then apply directly to our Embassy with the pre-application form and other required documents.
- 2. The required documents for visa application are listed below according to visa types. You need to upload all required documents to the website during your pre-application at www.visa.gov.tr and then bring them with you to the Embassy.
- 3. You are also required to make an appointment through www.visa.gov.tr. If you come to the Embassy without an appointment, your application will not be accepted. You will be informed when your visa application is finalized.
- 4. You must also present your passport at the time of application. However, after you submit your visa application, you can take your passport back until your visa application is finalized. If the visa request is approved, you must come to the Embassy with your passport to collect your visa.
- 5. The documents you submit for the visa application belong to the Embassy and cannot be returned to you. For this reason, you can add certified copies of the documents that you will need later to your application file instead of the originals, or you can get the original documents back after submitting the original and photocopy of the document in your application.

- 9. If the visit is carried out through a tourism company, the original letter from the tour operator stating the duration of the visit, the places to be visited and the purpose of the visit
- 10. A round-trip flight ticket reservation
- 11. Hotel reservation
- 12. Travel health insurance covering the period of stay in Türkiye
- 13. Visa fee (60 USD for single entry visa, 190 USD for multiple entry visa)

b. Business/Trade Visa:

- 11. Document proving the applicant's position in the company
- 12. Invitation letter from the company or an authorized person for inviting the applicant to attend a meeting, conference or event related to trade, industry or business; entrance ticket to fairs and congresses where applicable

- 11. Visa fee (60 USD for single entry visa, 190 USD for multiple entry visa)
- 12. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support the purpose of your visit, prove that you will leave Türkiye at the end of your visa period, and show your socio-economic status.

l. Freight Visa:

- 1. Valid passport (must be valid for at least "6 months + duration of your stay in Türkiye")
- 2. Visa pre-application form (available at www.visa.gov.tr)
- 3. 2 biometric photographs (taken within the last 6 months, 5x5cm in size, white background. The photo must comply with the photo standards specified by the International Civil Aviation Organization. - 4. Criminal record certificate (if you are not a Tajik citizen and reside in Tajikistan, you must submit a criminal record certificate from both your country of citizenship and Tajik authorities).
- 5. (If there is any) Your old passports and visas (even if they are not valid)
- 6. Original letter issued by the transportation company
- 7. Travel health insurance covering the period of stay in Türkiye
- 8. Visa fee (60 USD for single entry visa, 190 USD for multiple entry visa)
- 9. Apart from the documents listed above, it is recommended that you add any supporting documents to your visa application file that support the purpose of your visit, prove that you will leave Türkiye at the end of your visa period, and show your socio-economic status.
